Rents are not based on your income. ACCAP doesn't offer regular assistance to our tenants with paying their rent. For Apartments your household must have a monthly income that equals 2-times the monthly rent; for Townhomes* and Twin Homes monthly income requirement will be the greater of 2 ½-times the rent or 2 times the sum of the tenant rent plus utilities; and Single Family homes monthly income requirement will be the greater of 3-times the rent or 2 ½-times the sum of the tenant rent plus utilities.

*The Blaine University Avenue Townhomes monthly income requirement is 3 times the rent.

FAXED applications will NOT be accepted. Applications must be delivered to the ACCAP Blaine office.

Applications are available at ACCAP, 1201 89th Avenue NE, Blaine, MN. Phone calls will not be returned.

Deposit is the amount of the monthly rent and is due in full at the time of lease signing in addition to first month's rent.
